Welcome and Introduction

The Annual Performance Report provides an account of the Joint Organisation's performance for its six Member Councils and the Northern Rivers community.

The report details progress, achievements and outcomes against commitments identified within the Strategic Regional Priorities 2019 – 2022 and financial management over the 2018-2019 year.

In June 2018, the Northern Rivers Regional Organisation of Councils (NOROC) was formally dissolved and the Northern Rivers Joint Organisation was formed. The Northern Rivers Joint Organisation held its inaugural Board meeting in August 2018 and at this meeting a Chair was elected. An Interim Executive Officer had been appointed with primary responsibilities being to follow the pathway for setting up a joint organisation in accordance with the Joint Organisation Implementation Guide. The recruitment process for an Executive Officer (21 hours/week) concluded in December 2018, with the appointee commencing in January 2019.

The Annual Performance Report is an opportunity to acknowledge the regional initiatives and early progress towards achieving the vision articulated in the Strategic Regional Priorities document. It is also important to promote the outcomes that ultimately lead to a strengthening of the region, building on the demonstrated successes, unique character and diversity of member councils: Byron, Ballina, Kyogle, Lismore, Richmond Valley and Tweed.

This report also meets requirements under the *NSW Local Government Act (1993)* and will be presented to the Minister for Local Government, The Hon Shelley Hancock MP.

The Northern Rivers Joint Organisation wishes to publicly acknowledge the commitment and collaborative spirit of Mayors, General Managers and staff from the member councils. The financial investment and time commitment is significant, and reflects the shared values, commitment and generosity evident in the Northern Rivers community.

A number of member councils have demonstrated highly-valued leadership on key regional projects:

- Tweed Shire Council for taking carriage of the Biodiversity Legislation Reforms Project via its Senior Program Leader Biodiversity in collaboration with Local Government Support Officer (Biodiversity Reforms), North Coast, reflecting the Biodiverse Natural Environments reflecting the Biodiverse Natural Environments Strategic Priority.
- Richmond Valley Council for its work on the investigation of Waste to Energy opportunities and subsequent Waste Investment Report Project reflecting the Sustainable Energy, Water and Waste Strategic Priority.
- Ballina Shire Council for lodging a successful funding application on behalf of Northern Rivers
 Joint Organisation and recruiting an Environmental Officer under the NSW Environment
 Protection Authority's Council Regional Capacity Building Program enhancing the
 collaboration with key stakeholder, the NSW Environment Protection Authority.

The Northern Rivers Joint Organisation acknowledges the Bundjalung People, the traditional owners and custodians of the lands in our Region, and pays respect to the Elders past, present and emerging.

Performance and Value

A key responsibility of the Joint Organisations in meeting their core functions under the Local Government Act 1993 is to identify Strategic Regional Priorities and collaborate on strategies to achieve those identified priorities for the benefit of communities.

At a meeting of the Board of the Northern Rivers Joint Organisation at Tweed Shire Council on 8 February 2019, the Strategic Regional Priorities 2019 – 2022 document was formally launched. A workshop was then held where the five Strategic Regional Priorities were workshopped to identify the highest priority areas to pursue advocacy and project outcomes for the region.

1. Thriving, healthy and biodiverse natural environments

For the biodiversity and health of our waterways, habitats and wildlife to be protected and enhanced to deliver environmental, economic and recreational benefits for current and future generations of residents and visitors.

Project outcome

- Support the proposed Northern Rivers Watershed Initiative
- Advocate for change to forestry policy and planning regulations to encourage native forestation

2. Improved community wellbeing now and into the future

For our region to be able to offer its residents a range of affordable, appropriate housing choices and access to health care, mental health care, aged care and other services that enhance wellbeing

Project outcome

• Increased social housing, including crisis and emergency accommodation, to be on par with the state overage of 4% housing stock, within people's community of interest

3. A physically and digitally connected region

For our communities, businesses and visitors to be connected through a diverse range of safe, inclusive, low impact private and public transport options and high quality, reliable internet and mobile telecommunication services

Project outcome

 Accelerated road repair program through doubling the funding of the Commonwealth Roads to Recovery Program and the NSW Government's Regional Roads Repair Program over the next four years.

4. Innovative, sustainable energy, water and waste management

For our region to establish itself as a leader in renewable energy production; effective, sustainable water management; and innovative approaches to waste management to improve environmental and service delivery outcomes

Project outcome

- Develop a Northern Rivers Renewable Energy Investment Prospectus
- Lobby NSW Government for review and removal of waste levy.

5. A diversified, prosperous and sustainable regional economy

For our region to have a strong, diversified economy that provides increased employment and business opportunities and financial wellbeing for communities while protecting and maintaining our region's unique character

Project outcome

- Investigate removal of BCR criteria for funding applications
- Establish UNESCO Biosphere Reserve

KEY FUNCTION 1: PLANNING AND PRIORITISATION

The 2018 – 2019 highlights reflect progress and outcomes of efforts dedicated to promoting and achieving the identified Strategic Regional Priorities, and delivering on the core functions prescribed for Joint Organisations of Councils across NSW.

In follow up to its February workshop, the Board endorsed ten Advocacy Briefs. These briefs formed a solid platform for advocacy representations to Local, State and Federal members of Parliament and introductory meetings to pave the way for the pursuit of future funding opportunities to support and enable the implementation of key identified projects.

1. Thriving, healthy and biodiverse natural environments

<u>PROJECTS</u> - Advocate for changes to Forestry policy and planning regulations to encourage private native forestation AND the Northern Rivers Watershed Initiative.

NSW Minister for Water, Property and Housing - *Northern Rivers Watershed Initiative* An initial meeting was secured in May 2019 with the newly appointed Minister Pavey, following the formation of the NSW Cabinet. Follow up information was sought from Associate Member Rous Water to ensure Minister Pavey was provided with up to date information on river health classifications.

NSW Minister for Energy and Environment - Meeting held with the Minister's Deputy Chief of Staff in May to articulate the advocacy briefs relevant to this portfolio, including the Northern Rivers Watershed Initiative. The outcomes of this meeting included the commencement of a relationship with the Minister's office, paving the way for a further meeting secured with the Minister in October.

Australian Local Government Association's National General Assembly, Canberra - Advocacy material was provided to the Chair for presentation to Federal Ministers in June 2019:

- The Hon David Littleproud, Minister for Water Resources, Drought, Rural Finance, Natural Disaster and Emergency Management
- The Hon Mark Coulton, Federal Minister for Regional Services, Decentralisation and Local Government
- The Hon Susan Ley, Federal Minister for the Environment

Biodiversity Legislation Reforms Project - Northern Rivers Joint Organisation Funding of \$41,500

The Board confirmed financial support for this project in November 2018. Officers from Tweed Shire Council, Ballina Shire Council and Northern Rivers Joint Organisation Interim Executive Officer formed a committee to select the winning tender from the Request for Quotation process with the project aims being to:

- a) complete a regional assessment of the needs of each council to adapt development assessment processes to meet the new legislation, identify any existing opportunities for resource sharing and report this assessment with recommendations for specific requirements; and
- b) complete an assessment of the unavoidable biodiversity offset requirements likely to be generated from land already identified for development across the NRJO and report this assessment with

recommendations for specific further requirements, including whether a second stage analysis of potentially available stewardship sites is required.

This project has progressed well with a draft report for part a) due in September 2019.

Safe and Secure Water Program - An Expression of Interest was lodged for co-funding through the Safe and Secure Water Program: Northern Rivers Regional Bulk Water Supply Investigations. This project was assessed by the SSWP Technical Review Panel (TRP) in December 2018 and, following formal endorsement of the project by the Northern Rivers Joint Organisation, was deemed eligible to proceed to the next stage of the assessment process, i.e. submission of a detailed application for scoping study co-funding.

In early 2019, collaborative discussions were held with representatives from Rous Water and the Regional Water Strategies team (now part of the Department of Planning, Industry and Environment). In consultation with the Board and in light of preparation work required locally and the timeframe for the release of regional water strategies by State Government, agreement has been given to hold over a submission to this program until 2020.

Biodiversity Conservation Trust - Liaison established with Biodiversity Conservation Trust North Coast Regional Manager with introduction provided by Minister Kean's office. Discussions covered funding options and background information on:

- Conservation Partners Program
- Conservation Management Program
- Biodiversity Offsets Program

2. Improved community wellbeing now and into the future

<u>PROJECT</u> – Increased social housing, including crisis and emergency accommodation, to be on par with the State average of 4% of housing stock, within people's community of interest.

NSW Minister for Water, Property and Housing – Initial meeting following the formation of NSW Cabinet with Minister Pavey to introduce the advocacy brief and put forward a case for addressing the chronic housing shortages in the Northern Rivers.

Federal Minister for Families and Social Services - Advocacy brief provided to Chair for presentation to Senator the Hon Anne Ruston MP at the Australian Local Government Association's National General Assembly in Canberra.

Key Strategic Partners:

North Coast Community Housing – A not-for-profit company providing long-term social housing for people with special needs and residents with low and moderate incomes. Its footprint mirrors that of the Northern Rivers Joint Organisation and also extends south to Clarence Valley.

A strong collaboration has been formed to support the achievement of this strategic priority and discussions on regional solutions are ongoing.

Social Futures – A well-established social justice organisation based in Northern NSW that encompasses homelessness and housing supports, youth and family services, programs that promote genuine participation for people with disability, community sector support, professional development, and systemic advocacy.

The Northern Rivers Joint Organisation has established strong relationships with the leadership team and communications staff in relation to media strategies and support to the Northern Rivers Housing Forum campaign for the six urgent identified actions for the Northern Rivers and the Housing and Homelessness Fact Sheet: Key Northern Rivers statistics.

Housing Affordability Supply and Homelessness Forum - The Member for Lismore, Janelle Saffin MP, scheduled a roundtable discussion on housing affordability and homelessness and a report on outcomes will provide valuable input to advocacy representations around this priority area.

3. A physically and digitally connected region

<u>PROJECT</u> - Accelerated road repair program through doubling the funding of the Commonwealth Roads to Recovery Program and the NSW Government's Regional Roads Repair Program over the next four years.

Roads – The following strategies were promoted to address regional roads infrastructure needs:

- Use the Roads to Recovery model for the distribution of funding under the \$500m for local roads and the \$500m for timber bridges.
- Regional Roads handed back to the state can be maintained by Councils under the existing arrangements for the State Highways.
- Reassign the staff involved in the route assessments and design feasibility for the Pacific Highway to the strategic priorities identified by Transport for NSW.

Freight and Supply Chain Strategy

\$50,000 contribution by the Northern Rivers Joint Organisation - In January 2019, a draft report was considered at a consultation meeting with key stakeholders at Casino, where strategy lead author from Southern Cross University led a workshop to gain input from councils and the Department of Premier and Cabinet. Input to the draft was received from local industry and council staff as well as key stakeholders such as Rail and airport organisations. In keeping with the importance of alignment with broader State Government strategy, Transport for NSW officers were actively engaged.

This landmark strategy "From Roots to Routes: An innovative Vision of freight for the Northern Rivers" is a joint project with Northern Rivers Joint Organisation (NRJO), RDA Northern Rivers, NSW Department of Premier and Cabinet and Southern Cross University.

The key proposed network changes include increasing regional connectivity through improved B-Double access to the Port of Brisbane, Southern Queensland and Brisbane through the Summerland Way, Clarence Way. It advocates for modification to the Mt Lindesay Highway; and Tenterfield and the New England Highway through the Bruxner Highway west of Casino as well as improved access through Lismore.

The utilisation of the coastal railway and the under-construction Inland Rail corridor to create a rail shuttle to the Port of Brisbane and to Toowoomba/Wellcamp Airport is also a priority under the findings of the Strategy. This includes intermodal hubs at Kyogle, Casino and Grafton to provide direct access to rail from within the Region.

A key part of the Strategy is a new framework for regional collaboration that engages broadly with industry and agency stakeholders, to deliver on the initiatives in this plan and allow for capacity building and resilience within the region for the future. Monthly implementation meetings are ongoing between the project partners.

Advocacy brief and Strategy Executive Summary was provided to the Chair for representations to the Deputy Prime Minister and Minister for Infrastructure, Transport and Regional Development, the Hon Michael McCormack MP.

A positive relationship has been formed with Transport for NSW. This has enabled a two-way communication flow on alignment between progress with our regional plans and the state level transport strategies.

4. Innovative, sustainable energy, water and waste management

<u>PROJECTS</u> - removal or improved distribution of the waste levy AND develop a Northern Rivers Renewable Energy Prospectus.

Climate Resilience and Net Zero Emissions

Arising from strengthening of networks and relationships developed through the Regional Leadership Executive (RLE) meetings, liaison and teleconferencing with Senior Project Officer - Regional Preparedness, Climate Resilience Programs, Climate Change and Sustainability Division at DPIE, has been ongoing since the Executive Officer's initial RLE meeting in February 2019.

Tweed Shire Council was successful in Round 1 of the Increasing Resilience to Climate Change program and this will benefit all member councils:

To provide further opportunities for funding to be explored, the following initiatives were instigated:

- Presentation to GMs 1 July on North Coast Enabling Regional Adaptation (NERA) and how to use NERA as a supporting document for Local Strategic Planning Statements.
- Consider funding opportunities for Round 2 of the Increasing Resilience to Climate Change grants program.
- Increasing Resilience to Climate Change Round 2 Webinar held in July 2019 for council staff including presentation by Dr Stephen Bygrave, Director Climate Resilience and Net Zero Emissions Branch, Environment, Energy & Science Group, DPIE.

Federal Minister for Energy and Emissions Reduction - Advocacy brief provided to the Chair for Angus Taylor MP, at Australian Local Government Association's National General Assembly, Canberra.

NSW Minister for Energy and Environment - Meeting with Deputy Chief of Staff to Minister Kean in May to discuss Waste Levy and Renewable Energy Prospectus. Senior member of the NSW Environment Protection Agency staff was also in attendance.

Key Strategic Partner: Sustain Energy - Northern Rivers Renewable Energy Working Group

The request for membership of the group was accepted and attendance at meetings has proved beneficial for development of collaboration and funding opportunities relevant to project areas. The group is very committed to support NRJO in developing a Northern Rivers Renewable Energy Prospectus. Key priorities for 2019 are:

- Bioenergy
- Electric Vehicle strategy
- Low income households' solar access/energy poverty Solar Gardens, Buyers group/PPA
- Mid-scale Solar projects

Strategy Manager – Environment LGNSW – A meeting was held in May to introduce the waste levy advocacy brief and review alignment with LGNSW's advocacy position. A collated table of member councils' waste charges was also presented.

5. A diversified, prosperous and sustainable regional economy

<u>PROJECTS</u> – Investigate removal of BCR criteria for funding applications AND establish UNESCO Biosphere Reserve.

Advocacy representations were conducted in early 2019 to State Ministers and the Deputy Premier on the removal of Benefit Cost Ratios (BCRs) from Fixing Local Roads and Timber Bridges programs. The Board noted at its February meeting that BCRs had been removed from the Safe and Secure Water Program and therefore believed this to be a solid platform for advocating for further changes to this criteria that has disadvantaged rural and regional areas.

UNESCO Biosphere Status for the Northern Rivers - Preliminary partnership discussions held with Southern Cross University and the offer of data to assist in compiling an application offered through the Biodiversity Conservation Trust North Coast Regional Manager. Tweed Shire Council supplied valuable information on its investigations and reporting on UNESCO Biosphere Status application and governance process.

KEY FUNCTION 2: INTER-GOVERNMENTAL RELATIONS

One of the key functions of Joint Organisations is identifying and taking up opportunities for intergovernmental relations. The information provided under Key Function 1 section of this Annual Performance Statement also highlights the strong relationships that have been built. The Northern Rivers Joint Organisation has been proactive in this area and built on existing well-established networks and participated in a broad range of key Government stakeholder groups:

- Roundtable planning and engagement meetings and workshops with the Regional Water Strategies team (now part of the Department of Planning, Industry and Environment).
- As part of the contract for provision of support services by Regional Development Australia Northern Rivers, close collaboration occurs with involvement in shared projects.
- The NSW Marine Estate Management Strategy (MEMS) was released in August 2018 and in the lead up to the implementation plan being finalised, staff from NRJO member councils, Local Land Services and the Department of Planning Industry and Environment participated in a workshop to support this process, ensuring that local government authorities and agencies continue to work closely and collaboratively for successful project outcomes.

Council staff provided valuable input at various stages of MEMS development and there are opportunities for future projects to align with Councils' Coastal Management Programs (CMPs). NRJO welcomed the NSW Government's \$45.7m funding allocated to Stage One of this large body of work.

There is strong alignment between the MEMS initiatives and a number of NRJO key projects and advocacy areas focusing on river system health and water quality across the region.

- Valuable relationships have developed with all agency leads who attend the Regional Leadership Executive meetings and the Northern Rivers Joint Organisation takes an active role in the sub-committees convened by Regional NSW. Agencies include Public Works, Local Health District, Family and Community Services.
- Liaison with the Regional NSW occurs monthly with meetings on shared projects including projects that the Northern Rivers Joint Organisation invested in including Future Northern Rivers Campaign and developing a regional brand for NSW Northern Rivers. Both projects have come to fruition and the Brand launch proposed for February 2020.
- Active engagement with Director Regions, Northern for Local and Regional Planning at the Department of Planning, Industry and Environment in relation to significant changes impacting Local Government, for example the Local Strategic Planning Statements.
- Successful partnership with TAFE NSW and Regional Industry Education Partnerships at Training Services NSW to activate a Women in Construction program within most of the member councils.
- Active engagement with Transport for NSW as covered under the Freight and Supply Chain Strategy.

KEY FUNCTION 3: ADVOCACY AND LEADERSHIP

Members established the framework, policy and procedures for advocacy and leadership from the Northern Rivers Joint Organisation. As a group of Councils, the opportunity to advocate as a group that represents a larger population and geography is a powerful mechanism for promoting community needs.

All Five Strategic Regional Priority areas have been addressed with the relevant ministers and the Chair has reported extensively to the Board on successful outcomes of these advocacy efforts.

The following issues and areas were also highlighted as part of these discussions:

- Support for Local Government and the Joint Organisation Model and future funding
- Agriculture and Economic Development
- Renewable Energy
- Energy Infrastructure
- Financial Assistance Grants (FAGs) and the removal of the minimum per capita grant criteria
- Skills Shortages in the Northern Rivers
- Fire and Emergency Services Levy

Representations on behalf of members on positions of advocacy and leadership to the NSW Government and Australian Government representatives were made and have been acknowledged by the Board as very worthwhile.

It is considered good practice to ensure that Local Members of Parliament and apprised of the advocacy positions, so regular updates are provided. Meetings also occur with members of the opposition, with the view of establishing these networks and relationships for the long term future.

The Chair and Executive Officer are active members of the Joint Organisations' Executive Officer and Chairpersons Networks for Joint Organisations of Councils in NSW.


