7.1 ASSOCIATE MEMBER REPORT - DESTINATION NORTH COAST

Destination North Coast – Northern Rivers Joint Organisation of Councils Update

Market Conditions

Operator feedback indicates that the visitor market is returning to historical trends for this time of year. There has been a softening of demand and reduced levels of occupancy and forward bookings, reflective of greater choice for consumers with overseas destinations opening and border closures no longer being an issue.

DNC North Coast, Destination Management Plan Renewal

The <u>DNC</u>, <u>North Coast Destination Management Plan</u> is in the final stages of being refreshed and will cover from 2022-2030 mirroring the state-wide Visitor Economy Strategy 2030. The document is the key strategic document for the North Coast with the priorities and areas of focus outlined within having greater scope and opportunity to secure public funding moving forward.

Feedback from the one virtual session and six in person stakeholder sessions have demonstrated the continued importance of nature-based tourism and business events sectors with wellness and water-based activity appearing to be of increased importance. Ensuring that sustainability is central for any planning and development, which was a key theme of the original document, remains a priority for DNC and stakeholders moving forward.

DNC Project Updates

North Coast Festival of Flavour Open Weekend

The festival that was originally planned to be held in late March was moved to 5-7 June due to the flooding events. Whilst hampered by mixed messaging about the receptiveness of visitors to the Northern Rivers at the time the festival proved as success with 49 events being staged across the North Coast with an estimate cumulative attendance of 3.7k. Participating stakeholders expressed their desire for the event to staged again but this will be dependent on securing funding to facilitate the coordination and promotion of the festival.

<u>Aboriginal Product Development Mentoring program</u> – DNC and the NSW Aboriginal Tourism Operators Council (NATOC) who we have engaged to conduct this program are currently seeking Northern Rivers operators to participate. There remains an opportunity for up to four existing or emerging Northern Rivers businesses to partake in the program.

Northern Rivers Rail Trail Product Development Program

DNC and Wrey Consulting delivered a mentoring program for 20 Northern Rivers businesses. Each business received three hours of mentoring to develop their Rail Trail proposition. The mentoring program was aimed at ensuring that we have the critical mass of experiences available when the first section of the trail is launched, providing a diverse range of experiences, accommodation and support

services are on offer, improving the visitor experience and maximising the benefits to the visitor economy.

<u>Accommodation Reinvestment</u>

DNC in collaboration with Stafford Strategy have launched an Accommodation Reinvestment Mentoring program. The program will help owners and operators review their current performance, where investment is need to meet evolving consumer demand and to develop a strategy for reinvestment that will deliver the best return on investment.

RDANR DIRECTOR'S Report to NRJO Board Meeting Aug 2022

[1] Key Activities against RDANR Recovery Priorities:

1. Accommodation and housing

- **a.** Interviewed by consultancy engaged to research Accommodation issues and homelessness for Northern Rivers Community Foundation.
- **b.** RDA Network is holding a statewide housing summit. Opportunity to represent RDANR
- c. Tweed Shire Council's "Growth Management and Housing" Project Reference Group is progressing well. Outcomes will be delivered in the next couple of weeks.

- **c.** Business as Usual picking up and now receiving an increased number of unsolicited requests for information regarding investing/reinvesting in the region.
- **d.** Attended all three REDS consultation forums (Tweed, Northern Rivers, Clarence Valley)
- e. Attended North Coast Regional Plan (2041) consultation workshop.
- f. Attended Harwood Marine precinct strategy meeting (Waste to Wages project)

3. Industrial Land Audit

- **a.** (Chair) Successful consultants have been notified by NRJO Exec Officer. Fantastic support received by Byron, Ballina and Tweed planning and ED Officers
- b. Responded to CVC's Employment Land strategy call for submissions

4. Employment and Workforce Development

- **a.** (Chair) Northern Rivers Displaced Workforce Recovery Steering Committee is progressing well with ongoing interest from key stakeholders (lead agencies) and industry.
- **b.** Attended and promoted My Future Workforce Platform at the Lismore Jobs Expo which attracted over 2800 new entrants to the labour force, students and job seekers.
- c. Many local businesses experiencing extreme difficulty in hiring labour. Assisting these businesses to use alternative labour pools e.g. SERCO Correctional Centre, visas (eg Pacific Area Labour Mobility) scheme to ease pressure

5. CBD and Main Street redevelopment:

a. Attended Lismore Business Renewal workshops in Lismore, Nimbin and online

6. Local Buy, Supply Chain Development

a. A project to establish a locally based platform to assist recovering businesses (B2B) was put on hold during caretaker period.

Ms Kirsty McBain, MP has been announced as Minister responsible for the Regional Development Program.

Application submitted to Disaster Risk reduction Fund - \$1.4 million program divided equally among LGAs to reduce risk to life and property by enhancing Command and communication operations between community groups, responsible agencies and councils.

Consultation phase of RDANR Regional Recovery Plan has begun

Met with SCU project officers leading the development of the Northern Rivers Carbon Net Zero Project. RDANR can add value by connecting industry and other regional projects which support this project.

Associate Members Report - Scenic Rim Regional Council

Meeting date: 19 August 2022

Council adopts \$103.2 million 2022-23 Budget

On 11 July, Council adopted its 2022-2023 Budget at a Special Meeting in Beaudesert, announcing total expenditure of \$103.2 million for the 2022-23 financial year. The expenditure represents an increase of \$1.3 million from the previous year, which brings the budget back in line with previous years.

The budget has been shaped by a number of significant challenges in the region, particularly the need for extensive repairs to the road network after severe flooding, and the ongoing impacts of COVID-19, which continued to hamper day-to-day operations for Council's suppliers and employees.

A \$34 million capital works program will support Council's commitment to the recovery of infrastructure, repeatedly damaged since the end of 2021 as a result of impacts from significant rain events," he said.

\$31.54 million has been allocated for the essential upgrade and repairs of roads and bridges, which represents an ongoing investment in a well maintained, safe and interconnected transport network to serve the region's growing population as well as visitors to the region.

This Budget also includes an allocation of more than \$800,000 for drainage improvements to alleviate historical issues which have impacted the growth potential of key centres and had significant impacts on businesses. Kalbar and Beaudesert drainage projects will account for \$609,000 of this allocation.

More than half a million dollars has been allocated towards a series of new footpath works in urban and peri-urban locations across the region to increase accessibility, as well as minor works to maintain established footpaths.

\$4.01 million is scheduled for landscape maintenance and the upkeep of parks and gardens, and capital expenditure on a broad array of projects including repairs to a community centre, improvements to a caravan park, new picnic shelters, a new shade structure, water infrastructure, lighting upgrades, effluent disposal areas, playground updates and CCTV, lighting and resurfacing of internal roads at Council's waste transfer stations.

Council is grateful for the co-investment from both the Queensland and Australian governments, which collectively are contributing \$14.2 million for both operational and capital projects.

Scenic Rim Economic Snapshot boosts confidence in the region

The Scenic Rim's \$1.95 billion economy has withstood the cumulative impacts of bushfires, drought, floods and the pandemic to achieve a 4.45 percent increase in Gross Regional Product (GRP) for the year ending 30 June 2021, almost double that of Queensland's 2.31 percent overall growth. This remarkable growth rate reflects a diverse and resilient community focused on a sustainable and prosperous economy.

The Scenic Rim Economic Snapshot outlines key statistics for 2020-2021, highlighting regional performance, particularly in terms of jobs growth, investment (measured through value of building approvals) and GRP. The 4.45 percent growth rate has been driven predominantly by agriculture, forestry and fishing, wholesale trade and the construction industries. Unfortunately, not all industries escaped the effects of COVID-19, with the transport, postal and warehousing, accommodation and food service sectors negatively impacted.

At 6.8 percent, the region's unemployment rate is on par with the whole of Queensland, with strong employment growth in agriculture, health care and education.

Despite the pandemic and natural disasters, the region has added 1,500 local jobs during the past five years, with more than 140 net local jobs created in the year ending 30 June 2021. The establishment of more than 100 new GST-registered businesses in the Scenic Rim since March 2020 is another reason for optimism about increasing job opportunities in the region.

Council's recent approved grants and subsidies total \$75 million

Council has published its latest register of active grants and subsidies that includes projects totalling more than \$75 million. The funding includes almost \$26.5 million from the Australian Government, \$19.3 million from Queensland Government, \$8.3 million joint funding of projects from the Australian and Queensland governments and \$635,650 from the Council of Mayors (SEQ), matched by \$21 million Council contribution.

Council is proud of its strong track record of preparing robust and well-considered grant applications for competitive funding. It allows us to achieve infrastructure, social and economic outcomes for Scenic Rim residents, businesses and ratepayers.

Council to deliver Government Wireless Network communications system to aid disaster responses

Council will invest in Government Wireless Network (GWN) hardware to enable reliable communications during disaster responses. The GWN provides approximately 99% coverage of Southeast Queensland, and brings public safety agencies, including Queensland Police Service, Queensland Fire and Emergency Services, Queensland Ambulance Service and the SES into the same radio communications platform and frequency group to allow effective communications between multiple agencies.

The purchase of 30 handheld radios, 30 single unit chargers and two fixed station terminals will enable coverage across the Scenic Rim region for Council personnel and will replace antiquated radio systems currently in place.

Trials of GWN devices have addressed concerns about black spot coverage and identified options to use Council-owned communications aerials and to deploy mobile radio transmission sites to further extend GWN coverage if required.

The GWN is a fully managed service provided by an external telecommunications provider in conjunction with a major sub-contractor who install all equipment and provide technical support and maintenance 24 hours per day, 365 days a year.

Winter Harvest Festival 2022

The Winter Harvest Festival was back, bigger and better than ever following cancellation due to COVID in 2020 and 2021, the event up a delicious day of family fun at the Aratula Community Sports Complex on Saturday 2 July.

The long-running festival will cap off a huge Scenic Rim Eat Local Week program for 2022, starring over 125 fun and flavoursome events from 25 June to 3 July, attracting approximately 35,000 attendees.

The Winter Harvest Festival truly had something for everyone. From tasting tables to food trucks, rustic bars overflowing with beer, wine and spirits, a fashion on the field competition, cooking demonstrations, live music and kids' entertainment. Unfortunately due to weather, the always-competitive Bendigo Bank Kalbar & District Community Bank Tractor Pull event did not go ahead.

The Winter Harvest Festival brought the best of the Scenic Rim's local producers, suppliers, retailers and chefs together for an excellent celebration of the region.

Now in its 10th year, the **Scenic Rim Clydesdale Spectacular** held at Boonah Showgrounds on 11 and 12 June celebrated the history and heritage of the Clydesdale horse, which was used by pioneering Scottish and German families to transform the Scenic Rim's bushland into a leading agricultural area.

This is an event that attracts competitors, participants and spectators from around Australia, as well as overseas, and attendance has grown exponentially since its establishment in 2013, reaching almost 10,000 visitors in 2022.

The two-day event showcases the heritage, history and culture of the Clydesdale breed with a range of heavy horse competitions and driving displays as well as rare trades demonstrations by harness makers, blacksmiths and wheelwrights.

It also features workshops, working dog and horse displays, rides, live entertainment, markets, and traditional Scottish food.

The Scenic Rim Clydesdale Spectacular is supported through Council's Regional Events Program Grants. With an estimated economic benefit to the region of more than \$3million, the \$10,000 grant represents an excellent return on investment for the Scenic Rim.

EmpowHer initiative hikes into national innovation award

The Scenic Rim's EmpowHER hiking program was nationally recognised, taking out the Programs and Activities Award at the 2022 Australian Sport, Recreation and Play Innovation Awards, held in Melbourne on 11 July.

he annual awards, hosted by the National Sports and Physical Activity Convention 2022, recognise innovative projects that encourage the community to be more active.

The EmpowHER Hiking program empowers women and girls to explore the spectacular Scenic Rim whilst building confidence, fitness and participation through hiking. The program aims to increase the physical activity of women and girls by reducing barriers to participation, including affordability, time flexibility, transport and self-motivation.

Seventy-five guided walks, 80 per cent of which sold before the program commenced, and catering for a range of abilities, were hosted between February and June 2022, with 390 women between the ages of 10 and 76 years lacing up their hiking boots to participate.

The EmpowHER Hiking Program is the only program in Queensland, and possibly even in Australia, involving multiple operators with a specific focus on women and girls, and set in an enriching region like the Scenic Rim.

The innovative program offered guided hikes at a subsidised price for participants in an initiative jointly funded by the Queensland Government's ActiveKIT program in partnership with Health and Wellbeing Queensland and Scenic Rim Regional Council.

Tamborine Mountain awarded Queensland Top Tourism Town

Tamborine Mountain was awarded top honours at the Queensland Tourism Industry Council's (QTIC) 2022 Top Tourism Town Awards, held 13 June in Brisbane.

The Awards recognise towns whose tourism operators, businesses and community groups work together to encourage tourism and offer outstanding experiences for visitors.

Public voters from across Australia and beyond selected Tamborine Mountain as a favourite destination for weddings, honeymoons, special events and extra-long-weekend adventures.

Tamborine Mountain Chamber of Commerce and Industry worked in close partnership with Scenic Rim Regional Council and local tourism operators and businesses to showcase Tamborine Mountain's exquisite wedding and reception venues, five-star dining options, outstanding wineries and breweries, unique shopping, incredible rainforest experiences and luxury accommodation offerings.

The Scenic Rim region was well represented at the awards, with Canungra, Boonah and Kalbar also included among 23 towns that made the shortlist.

Tamborine Mountain will now compete in the National Top Tourism Town Awards to be held later this year.

Queensland Championship Rowing Regatta to be held at Scenic Rim later this year

Council are proud to partner with Rowing Queensland in bringing the 2022 Queensland Grade Championship Rowing Regatta to the Scenic Rim following a funding boost to support the event. Council, in partnership with Rowing Queensland, were successful in receiving \$50,000 from the Regional Sports Events Fund supported by the Australian Sports Commission. The funding will contribute to assembling the regatta which is scheduled to be held on the weekend of the 3 and 4 December 2022.

Hosting an event of this scale is also hugely beneficial to reinvigorating the local economy after a challenging two years. The region's fantastic hospitality and tourism providers will be thrilled to host the influx of visitors this event will bring.

Lake Wyaralong has also been identified as one of the venues for the Brisbane 2032 Olympic and Paralympic Games that will feature rowing and sprint canoeing events, demonstrating the region's potential to host world-class sporting events.

Council's Shop Scenic Rim gift card program to keep money local

Scenic Rim Regional Council is supporting local businesses and the regional economy with the launch of *Shop Scenic Rim*, a gift card program that will encourage people to shop locally. Jointly funded by the Australian and Queensland Governments under the Disaster Recovery Funding Arrangements, the program will enable residents and visitors to purchase gift cards that will be redeemable in participating local businesses.

Using an EFTPOS-based system, shoppers will be able to purchase *Shop Scenic Rim* gift cards at several local businesses, and online. These cards can then be used just like a normal EFTPOS card for purchases at participating businesses within the Scenic Rim.

'Go Local, Grow Local' Partnership Program is a key deliverable of Council's Regional Prosperity Strategy 2020-2025, which supports the vision shared by Council and the community, for a region that enjoys a sustainable and prosperous economy. Establishing this program was thankfully accelerated by the government's funding support.

Appropriately, the program was launched on Friday, 20 May at the Business Breakfast held during Queensland Small Business Month, a four-week program celebrating small businesses and highlighting the importance of the business sector to the state's economy.

The gift cards will keep money circulating in the community, prompting shoppers to patronise local businesses and allowing participating businesses to capitalise on the loyalty of the region's close-knit communities and enthusiastic visitors. The 'multiplier' effect, meaning that money initially spent in local businesses will continue to circulate locally, can see a \$100 spend having an \$180 impact on the local economy. Additionally, modelling conducted using the .id economic impact model indicates that every \$500,000 spent within retail businesses supports five local jobs.

Smart strategy promotes adoption of technology and data to drive a prosperous, connected and sustainable region

On 21 June 2022, Council endorsed a landmark strategy for investment in smart technologies and commitment to smart collaboration, planning, design and local services, while aligning with the values of the region, to deliver a vibrant and prosperous economy and community.

The first of its kind, the Scenic Rim Smart Region Strategy 2022-2032 will leverage new technologies, innovation and data to enhance the liveability, workability and sustainability of the region.

This strategy was developed following consultation with local residents and business operators to create a shared vision for the region's use of new technologies and data and to allow local businesses and communities to embrace and adapt to changing global digital trends.

The vision of the strategy is to be an accessible and serviced region with a vibrant, sustainable and prosperous economy and community. This will be achieved through investment in smart technologies and innovation focused in the areas of:

- Economy: leading an innovative and progressive economy attracting growth and investment.
- Place: Enabling resilient and sustainable management to future-proof communities and the environment.
- Community: Creating inclusive, liveable, and supported communities that attract and retain residents.

Council adopts minor amendment to Scenic Rim Planning Scheme 2020 to incorporate updated flood studies

Mid June, Council adopted a minor amendment to the Scenic Rim Planning Scheme 2020 at this week's Ordinary meeting to incorporate two flood studies for Veresdale and Canungra.

The two recent flood studies incorporate climate change projections and enable Council to provide the most up to date flood levels and to inform changes to land use and new building works.

The Veresdale Flood Study (February 2022) has been developed to improve flood hazard information in the Cyrus Creek catchment of Veresdale, to inform development and building work. The Canungra Township – Detailed Flood Study (Version 2, July 2021) updates the existing flood model by applying a more suitable 'roughness' level that is reflective of the built environment and vegetation in the Canungra township area. The updated model results in only minor changes to the existing flood hazard mapping.

User-friendly planning scheme platform to go online

Council's investment in an online planning platform will pay dividends for Council and the community through time and cost savings from early 2023. Council's 2022-2023 Budget includes \$70,000 for the *Scenic Rim Planning Scheme 2020* e-Plan Project to streamline town planning enquiries.

The new e-Plan will combine mapping and planning scheme documents in a single, user-friendly platform providing enhanced service delivery in line with current community and industry expectations.

Council continues to strive to provide a high level of customer service and this project is another significant business improvement initiative. the new e-Plan will deliver a user-friendly format combining mapping and planning scheme documents in a single platform which includes a property enquiry function and the ability to extract information to support development applications.

The introduction of the e-Plan represents another milestone in the region's journey following the adoption of the Scenic Rim's first ever unified Planning Scheme in 2020.

This online platform will play a valuable role in the growth of the region as the Scenic Rim continues to power ahead, with some 10,000 additional dwellings and essential infrastructure needed to meet the projected population growth between now and 2041.

The *Scenic Rim Planning Scheme 2020* is expected to be delivered in an e-planning format by December 2022 and accessible on Council's website by February 2023.

Severe wet weather, COVID-19 and limited supplies impact 2021-2022 Capital Works program delivery

As of mid-April 2022, all planned capital projects have been impacted as a result of ongoing wet weather, the COVID-19 pandemic and industry supply delays, with impacts expected to be ongoing while Council works to undergo further emergency repairs as a result of the most recent period of severe and associated wet weather.

Many specialist external contractors and sub-contractors have been experiencing back-log commitments due to these same issues. The number and severity of these weather events has exceeded the additional contingency time accounted for in the delivery of most projects. Landscaping materials, concrete, steel and electrical products have limited availability, and specialist machinery we need to carry out these projects to the desired standard are not readily available, and when they are, there's long wait times. We understand this is a state-wide issue.

Council officers also are continuing to undertake a growing list of assessments for provision to the Queensland Reconstruction Authority where the total number of damage points has exceeded 2,000 across Council's 1,756-kilometre road network as a result of the three disaster activations for last financial year.

Head Road Carney's Creek remains closed for public safety, works delayed due to ongoing wet weather

Council has engaged a contractor to undertake a series of important works to replace approximately 200 metres of guard rail originally damaged by bushfires in 2019 at Head Road near Brett Road at Carneys Creek, which were anticipated to start at the end of May, 2022.

Recent wet weather and flooding has caused additional damage to the previously damaged site and to further sections of Head Road, resulting in the closure of the road.

the impact of repeated wet weather events have hindered the ability to fix Head Road, with the recent weather event causing further damage and that a continued road closure is required to ensure the safety of the travelling public.

Head Road will remain closed while works occur with an alternate route available through the Cunningham Highway or White Swamp Road, noting the White Swamp Road contains unsealed sections.

The works on Head Road are just one of a large number of works across the road network that Council crews are responding to as efficiently as possible to make them safe for residents and travellers to the region.

Approved Biodiversity Implementation Plan provides momentum for biodiversity vision in the Scenic Rim

The implementation plan was a key action from the Scenic Rim Regional Council's Operational Plan 2021-2022, which includes an Area of Focus on biodiversity. It outlines the recognition, preservation and enhancement of the region's unique environment and natural resources.

A recent mid-point review of the 10-Year Biodiversity Strategy inspired the Council to develop an implementation plan for the remaining five years, with the aim of providing a renewed direction and outlining the next steps towards achieving the region's biodiversity vision.

It identifies a detailed work plan for Council's Biodiversity and Climate Change team and provides a clear line of sight to the team's work on preserving and enhancing the region's biodiversity.

In addition, the document identifies actions delivered in partnership with other Council teams, providing insight into internal and external partnerships required as part of the implementation plan.

Council recently adopted the *Scenic Rim Biodiversity Strategy 2015-2025 - Report Card 2015-2020*, which provides an update on implementation of the Strategy in its first five years, from 2015 to 2020, as well as further information about the state of biodiversity within the Scenic Rim region.

Highlights include that Council had provided 393,095 native trees through the One Million Trees Program by 2020 and over 13,000 hectares of private land was included in the Habitat Protection Program.

Council is proud to partner with a range of organisations and individuals who have each helped in developing and delivering actions of the strategy, including delivering 143 Environmental Grant projects valued at \$477,882.

The Report Card also brings to light some of the challenges the region is facing including the reduction in native vegetation cover, with a loss of almost 1,300 hectares. Furthermore, between 2015-2020, the number of threatened species increased significantly at both a state and national level, with more species nearing extinction.

Scenic Rim celebrates withdrawal of permits for coal seam gas exploration

Two tenements to explore the operation of coal seam gas in the Scenic Rim have been withdrawn following a Ministerial announcement on 24 June. Minister for Resources Scott Stewart advised company Arrow Energy has withdrawn its application to renew the permits to explore coal seam gas just outside of Beaudesert.

The announcement came after Arrow Energy's ten year campaign encountered opposition from locals across the Scenic Rim in a bid to halt the exploration. The withdrawal is a huge win for the region and ensures that the natural beauty of the area remains unharmed.

The region's priorities revolve around the stunning environmental precincts, including six significant National Parks, our high performing agricultural precincts and our unique network of characterful communities. Our acknowledgement as a world recognised destination is based on these foundations.

Council releases first Customer Satisfaction Survey Results

At its Ordinary Meeting held 21 June, Council adopted the final report on the results of the customer satisfaction survey, the first ever to be conducted through the Let's Talk Scenic Rim community engagement platform which launched in February.

Council's waste services rated highly, with 76 per cent of respondents being either very satisfied or satisfied with their bin service and 62 per cent very satisfied or satisfied with their recycling and waste stations. Council-owned facilities also received positive feedback as 60 per cent of respondents were either very satisfied or satisfied with the accessibility of parks while 44 per cent were very satisfied or satisfied with park maintenance.

This reflects the concerted efforts of Council through its Playground Strategy which, since 2017, has been focused on the construction of new playgrounds and playground upgrades right across the region. This has included the playground at Billabong Park at Kooralbyn, DJ Smith Park at Canungra, Jubilee Park at Beaudesert, Springleigh Park at Boonah, Lions Park at Tamborine Mountain, the Kalbar Civic Centre playground upgrade, Moffatt Park at Aratula, Bowman Park at Mount Alford, the Tiny Tots Playground at Boonah, the Tamborine Memorial Hall playground, and Queen's Park at Harrisville and the current upgrade to the Rathdowney Memorial Grounds playground.

Council's library programs were also well received, with 45 per cent of respondents being very satisfied or satisfied, while respondents said they were either very satisfied or satisfied with Council's environmental programs.

7.4 NORTHERN RIVERS JOINT ORGANISATION STRATEGIC REGIONAL PRIORITIES

PREPARATION OF STRATEGIC REGIONAL PRIORITIES 2023-2026 STATEMENT

Purpose

The purpose of this report is to seek the approval of the Northern Rivers Joint Organisation Board for the budgetary allocation needed to prepare a new statement of strategic regional priorities as required by the *Local Government (General) Regulation 2021*.

Background

A principal function of the Northern Rivers Joint Organisation ('NRJO') under section 400R of the *Local Government Act 1993* is to establish strategic regional priorities for the Northern Rivers area. In doing so, the NRJO must consider any relevant strategies or plans of its member councils and the NSW Government.

Regulation 397H of the *Local Government (General) Regulation 2021* requires the NRJO to have in place a publicly available statement setting out its strategic regional priorities, which must be prepared no later than 12 months after an ordinary election of councillors for its member councils. In preparing a proposed statement of regional priorities, the NRJO must consult with its member councils.

The NRJO's current Strategic Regional Priorities 2019–2022 statement was adopted at the Board's ordinary meeting on 2 November 2018 [at 02112018/8]. Following the latest NSW local government elections on 4 December 2021, the NRJO needs to prepare and publish a new statement of strategic regional priorities for the 2023–2026 period by December 2022.

Proposal to prepare the Strategic Regional Priorities 2023–2026 statement

In June 2022, an appropriate proposal was received from a suitably qualified consultant to undertake a review and update of the NRJO's current strategic regional priorities and prepare a new statement of priorities for the 2023–2026 period.

The NRJO's 5 current strategic regional priorities are:

- 1. thriving, healthy and biodiverse natural environments
- 2. improved community wellbeing now and into the future
- 3. a physically and digitally connected region
- 4. innovative, sustainable energy, water and waste management
- 5. a diversified, prosperous and sustainable regional economy.

While the review will build upon the current statement of priorities (reshaping existing or introducing new priorities as needed), ensuring the new statement of priorities focuses on the region's recovery and rebuilding needs after the February 2022 flood disaster will be paramount.

Along with considering the community strategic plans of member councils as well as relevant regional and state plans/programs, preparation of the new statement will involve direct engagement with the Board and member councils (including a strategic planning workshop).

At this stage, it is anticipated a draft Strategic Regional Priorities 2023–2026 statement will be ready for the Board's feedback sometime in October 2022 – before a final statement is presented for formal adoption at its ordinary meeting scheduled in November 2022.

A total budget allocation of \$25,000 is sought to prepare the NRJO's new statement of strategic regional priorities for the 2023–2026 period. This budget allocation also includes the expected cost to produce a properly designed public document suitable for publishing on the NRJO's website as well as an allowance for contingency costs.

Conclusion

Following the latest NSW local government elections in December 2021, the *Local Government (General) Regulation 2021* requires the NRJO to prepare and publish a new statement of strategic regional priorities for the 2023–2026 period by December 2022.

The NRJO has received a proposal from a suitably qualified consultant to prepare the new statement of priorities, which is considered appropriate. A total budget allocation of \$25,000 is needed to prepare the statement, produce a public-facing document and cover contingency costs.

RECOMMENDATION:

THAT the Board approve a budget allocation of \$25,000 to prepare and produce the Northern Rivers Joint Organisation's Strategic Regional Priorities 2023-2026 statement.

7.7 NORTHERN RIVERS INDUSTRIAL AND EMPLOYMENT LANDS AUDIT

NORTHERN RIVERS INDUSTRIAL AND EMPLOYMENT LANDS AUDIT PROJECT

Purpose

The purpose of this report is to seek the approval of the Northern Rivers Joint Organisation Board for the budgetary allocation needed to undertake an industrial and employment lands audit across the region.

Background

The Executive Officer previously reported to the Board [at 12112021/6] that the Northern Rivers Joint Organisation ('NRJO') has been provided an additional \$150,000 in funding under Round 2 of the NSW Government's Joint Organisation Capacity Building Fund.

One of the 4 projects proposed and approved for this funding is an audit of available industrial and employment land in the Northern Rivers region.

The audit project is a key action towards achieving Goal 12 of the NRJO's strategic regional priorities — that is, to deliver a strong, diverse regional economy which provides local employment by attracting new enterprises, enabling existing enterprises to innovate and expand, and offering the conditions required for emerging industries to flourish.

An adequate supply of suitably located and zoned industrial and employment land is considered vital to ensuring and promoting the region's economic growth and sustainability.

At its 4 February 2022 ordinary meeting, the Board was informed [at 04022022/8] that a brief was to be prepared and sent to market seeking to engage a suitably qualified consultant to undertake the required audit. The original budget estimate was \$70,000 (\$45,000 from NRJO).

Requests for quotations have now been invited to complete an audit of industrial and employment lands across the 6 local government areas of Ballina Shire, Byron Shire, Kyogle, Lismore City, Richmond Valley and Tweed Shire.

Audit project proposal and budget

In July 2022, an appropriate proposal was received from a suitably qualified consultant (HillPDA Consulting) to undertake the Northern Rivers Industrial and Employment Lands Audit project.

HillPDA Consulting is well-positioned to undertake the regional audit having recently completed several similar projects across NSW including those for the Byron Shire, Clarence Valley and Ballina Shire local government areas. This previous work will form part of the current audit, thereby reducing the amount of time required to complete the project.

Essentially, the project's scope involves the following 3 deliverables/outcomes:

- Region-wide audit to understand the amount and status of current industrial and employment land stocks.
 - Along with targeted industry consultation, the audit will also include analysis of socio-economic, employment and industrial trends as well as planning provisions and land constraints.
- Twenty-year demand forecast to identify the additional supply of industrial and employment land needed across the region.
 - The forecast will include employment/industrial land demand modelling as well as analysis of future employment/industrial land characteristics and barriers to growth.
- Concise, highly visual final report distilling key findings and recommendations.

A total budget of \$100,000 is required to undertake the Northern Rivers Industrial and Employment Lands Audit project.

The project is being delivered in collaboration / partnership with associate member Regional Development Australia – Northern Rivers. As such, a budget allocation of \$75,000 is required from the NRJO as the remaining \$25,000 will be funded by Regional Development Australia – Northern Rivers.

Conclusion

The NRJO received funding under Round 2 of the NSW Government's Joint Organisation Capacity Building Fund to undertake 4 projects – one of which is an audit of available industrial and employment land in the Northern Rivers region.

A key action towards achieving Goal 12 of the NRJO's strategic regional priorities, the audit project will support planning for the region's economic growth and sustainability by capturing current industrial and employment land stocks and forecasting the demand for such lands over a 20-year period.

The NRJO has received a proposal from a suitably qualified consultant to complete the required audit, which is considered appropriate.

A budget allocation of \$75,000 is needed from the NRJO to undertake the project as associate member Regional Development Australia – Northern Rivers will be funding the additional \$25,000 required to complete the audit.

RECOMMENDATION

NORTHERN RIVERS RAIL TRAIL GRANT APPLICATION

Purpose

The purpose of this report is to inform the Board about a grant application to be made by the Northern Rivers Joint Organisation in relation to the Northern Rivers Rail Trail.

Background

The Northern Rivers Joint Organisation ('NRJO') Chair and Executive Officer recently met individually with representatives from Northern Rivers Rail Trail Inc ('NRRTI') regarding a grant application for the business case and strategy development of the Northern Rivers Rail Trail.

NRRTI is seeking to partner with the NRJO to apply for funding under a recently announced NSW Government grants program, the Regional NSW – Business Case and Strategy Development Fund.

At its 8 August 2022 meeting, the NRJO General Managers' Advisory Committee considered the NRRTI's request for the NRJO to be the lead organisation for the grant application.

Northern Rivers Rail Trail grant application

Grants under Stream One (Regional Significance) of the \$24 million Regional NSW – Business Case and Strategy Development Fund are available to:

- local councils or Joint Organisations of Councils
- infrastructure providers such as telecommunication, energy, or water companies
- peak bodies such as business, industry, and community associations
- cooperatives
- tertiary educational institutions
- incorporated not-for-profit organisations.

Co-contribution is not required under the grant criteria. The grant application process can also include a contingency amount up to 25% of the quoted costs to cover project management, administration and contingency costs.

NRRTI has provided a short summary of their vision for the rail trail's business case and strategy development as well as the basis for the grant application, this has also been amended to incorporate Byron Shire Council solar train opportunities. (see Attachment 1).

The General Managers' Advisory Committee considers the rail trail's business case and strategy development to be consistent with the NRJO's strategic regional priorities and, as such, worthy of the NRJO taking the lead in making a grant application.

If the grant application was successful, the NRJO would need to engage a dedicated project manager to lead the business case and strategy's development. An important part of this process would also be to work closely with member Byron Shire Council to look at opportunities to incorporate the solar train's expanded use of the region's rail corridor in conjunction with the rail trail's development between Byron Bay and Mullumbimby and also to consider the feasibility of rail beside trail between Byron and Bangalow. The following additional points have been raised by Byron Council for consideration as part of the business case and strategy process:-

- Examine viability of on-rail and off-rail formation (Rail with Trail) from Byron to Mullumbimby and Mullumbimby to Bangalow.
- Identify the required LEP amendments to enable potential economic activation within the rail corridor and adjoining lands
- Develop an overview Northern Rivers Rail Trail map demonstrating linkages to cycle, hiking and water activation

Given applications for Stream One of the Fund close 24 August 2022, grant application preparation activities have commenced.

Conclusion

The NRJO has been contacted by representatives of the NRRTI requesting it to be the lead organisation regarding a grant application under the Regional NSW – Business Case and Strategy Development Fund for the business case development of the Northern Rivers Rail Trail.

The General Managers' Advisory Committee considers the rail trail's development to be consistent with the NRJO's strategic regional priorities and, as such, worthy of the NRJO making a grant application by 24 August 2022.

It is proposed that the Northern Rivers Joint Organisation (NRJO) apply for funding to complete a business case for the development of the Northern Rivers Rail Trail (NRRT) on the disused Casino-Murwillumbah rail corridor.

NRRT projects in Richmond Valley and Tweed Shires have already commenced and Lismore has funding for Bentley to Lismore. But several issues remain unresolved and the trail needs to be completed to deliver significant benefits to the region. In particular, the business case needs to:

- Update capital and ongoing costs, economic analysis, financial appraisal and proposed funding to complete unfunded section (Lismore to Crabbes Ck)
- Examine and consult on governance arrangements and make recommendations
- Review all corridor land for potential revenue options and develop a viable financial model for ongoing management that does not impact on councils' finances
- Provide an opportunity for submissions from potential major sponsors
- Develop staging options for delivery of the trail that consider timing of other potential joint uses of the corridor
- Include consideration of the proposed Bangalow to Ballina connector link and the relationship of the trail with Kyogle
- Consider and review other (than cycling and walking) opportunities the unused corridor provides eg environmental restoration, establishment of wildlife connecting corridors, horse riding etc

To minimise financial risk, the NRJO can request an additional 25% of the quoted cost:

to cover contingency, project management and administration costs.

The development of the business case does not place any onus on the NRJO or other organisations to deliver the rail trail. Rather, it provides a sound basis for councils in this region to make decisions about development of their sections of the corridor. The business case also gives the NRJO a region-wide project that will support the local economic recovery.

7.10 FINANCIAL REPORTS

Purpose

The purpose of this report is to provide DRAFT financial results for the year ended 30 June 2022 for the Northern Rivers Joint Organisation (NRJO).

Background

A DRAFT copy of the Profit and Loss, Balance Sheet and Jobs Profit and Loss as at 30 June 2022 is presented in this report.

Rous County Council took over responsibility for the NRJO's accounting in June 2022. Rous's Financial Accountant is finalising the accounts and preparing the Financial Statements in accordance with the Office of Local Government Code of Accounting Practice. The draft reports replicate the formatting and presentation the NRJO is familiar with receiving to, except for some additional breakdown of the project expenses.

The draft operating result is an operating loss of \$260K against a forecast operating loss of \$770K. The extent of the forecasted operating loss represents the timing impact of incurring project expenses for money actually received in prior financial years. Expenditure on these incomplete projects will continue into the next financial year.

In April 2022 the NRJO sought and received an extension of time for lodgement of the Financial Statements from the Office of Local Government (OLG). The extension provides an additional 2 months to 31 December 2022 to lodge the Financial Statements. The NRJO's contracted auditors, Thomas Noble and Russell (TNR) will commence their audit on the 24 October 2022.

The process for the completion and submission of the year-end financial accounts is as follows:

- The Accountant and Auditor prepare the audited accounts which are then signed by the NRJO, approved and issued by the Audit Office and submitted to OLG by 31 December 2022.
- We then advertise on our website that the next meeting of the Board will include the Audited Financial Statements and Auditor's Reports and notify the date of the Board meeting.
- We then include these reports as part of the Annual Performance Statement that will be approved by the Board.
- Once the Annual Performance Statement is approved by the Board it is submitted to OLG and placed on the NRJO website.

Rous's Financial Accountant is reviewing all financial information required to be presented to the NRJO board and will be making changes progressively once the 2022 Financial Statements are completed. This is to ensure the presentation of the reports communicate effectively the financial position of NRJO.

As you would be aware, housing supply and affordability on the Northern Rivers is at crisis point, with the catastrophic February/March 2022 floods, which displaced thousands of residents, intensifying the problem.

Kyogle Council feels strongly that local government needs to work in partnership with other levels of government to address the issue and at it's 11 April 2022 meeting resolved to:

Write to the Northern Rivers Joint Organisation (NRJO) requesting urgent and immediate advocacy be undertaken with State and Federal Government Ministers to address the housing crisis occurring on the Northern Rivers including, but not limited to, social house which is currently below the State average.

There has been a lot of discussion at various levels of government about the need to build around 42,000 homes for the next 40 years to meet demand. This is insufficient. Population pressure will continue to build through time and the Northern Rivers, in particular, will continue to feel that pressure. Wind up of MyRoadInfo platform and transition to OneRoad

Dear Michael,

At its 20 May 2022 ordinary meeting, the Northern Rivers Joint Organisation Board considered a report on the long-planned wind up of the MyRoadInfo platform and transition to Transport for NSW's new back end solution that feeds into Live Traffic NSW, OneRoad.

Subsequently, I write to inform you that from **30 June 2022**, the front end of the MyRoadInfo website will no longer be available for the community to use and access local road information.

Any community member who visits the MyRoadInfo website after this date will instead be redirected to the Live Traffic NSW site.

It is important your council's public information resources and channels are updated to reflect this change as soon as possible please.

Local road information provided to the MyRoadInfo platform by your council and other member councils is already shared with and available via the Live Traffic NSW online service.

Transport for NSW is currently finalising development of a new online platform that will allow each LGA to share live traffic information to a central hub that gets published to Live Traffic.

The goal is to have one central source of truth for motorists, freight operators, and third-party providers, that is managed by the Transport Management Centre.

With OneRoad, we can help road users make informed travel decisions, and plan and complete their journeys safely. To do this, we need accurate, reliable and up to date information across all roads in NSW. With the right information at the right time we can:

- inform our road users with real-time information on traffic conditions, incidents, hazards and major events on all roads in NSW
- enable road users to make the right decisions and choices

- help save lives by giving people the right information at the right time
- reach more people, as the solution is designed for data sharing and collaboration with third-p arty navigation systems like Google Maps and Apple Maps, Waze, TomTom.

Recent advice from Transport for NSW indicates its solution -will be finalised by Quarter 3 of 2022 with councils using MyRoadInfo selected to go live with OneRoad first.

Given this advice, the Board resolved to put in place an interim arrangement to ensure local road information continues to be available on the Live Traffic NSW platform in the meantime.

Essentially, operation of the MyRoadInfo platform's back end (non-public facing) administration system is to be extended by up to six months (only) so that local road information can still be shared with the Live Traffic NSW platform until Transport for NSW's new system is up and running.

As part of finalising and rolling out its new system, Transport for NSW will be engaging directly with all NSW councils in the next few weeks. This will include workshops to demonstrate and test the system, seek feedback and provide training.

To help facilitate the engagement process, I would appreciate if you could provide me the details of your council's best point of contact please so I can pass these on to Transport for NSW by Friday 3 June 2022, hoping to commence engagement by mid June.

RE: Public exhibition of Byron Shire's short-term rental accommodation planning proposal

I write on behalf of the Northern Rivers Joint Organisation to seek your assistance with expediting the public exhibition of a vital planning proposal put forward by one of its member councils to address rental accommodation issues in the Byron Shire local government area.

In light of the exacerbated housing crisis following the recent floods that devastated the Northern Rivers region, Byron Shire Council's short-term rental accommodation planning proposal is fast becoming an increasingly critical, much-needed initiative.

By providing appropriate planning controls to manage non-hosted holiday letting in the Byron Shire, the proposal aims to find a suitable solution to maintaining housing for local residents while supporting the area's important visitor economy.

Following preparation of an Economic Impact Assessment late last year, the Council submitted an amended planning proposal as well as application to alter its previous Gateway Determination to the Department of Planning and Environment in February 2022.
